## **1. The name and object of the competition**

International Molkky Organisation (IMO) is organizing the Design Competition for the future medals which will be put into play as part of the Nations Cup organized by IMO. These medals will be awarded to the winner of the Nations Cup taking place on the week of the Molkky World Championships.

The goal of this competition is to propose medals and ensure its production, the cost of this project being borne by IMO.

These medals will be awarded to the top 4 nations at the Nations Cup. Each nation of the top 4 will be awarded 4 medals whose players can keep.

## **2. The theme**

The proposed theme is the "MEDALS FOR THE World Championships".

### THE GENERAL SPIRIT OF THE COMPETITION :

The jury will take particular account of projects that are formally and conceptually adapted to the constraints of air transport, particularly in terms of size and weight, manufacturing cost and strength. The choice of materials in particular, as well as the manufacturing process, must take these constraints into account.

### **3. Participants & conditions of participation**

The competition is open to people over 18  
All project documents must be written in English.

Participation can be done individually or collectively (collective of 4 people maximum). It is forbidden to submit the same project under different names under penalty of exclusion from the competition. IMO does not reimburse the costs incurred by candidates to participate in the competition.

### **4. Projects**

Participants should take into account the following points:

- The medals must be original and in particular must not already exist on the market,
- The medals must be able to tie a ribbon.

The size of the medal must fit in a 8cm x 8 cm square.

The price of the medal should remain within reasonable limits and will be a decisive point when comparing the different proposals.

The design shall allow the medals to be in Gold, Silver and Bronze to reward the 3 best teams in the tournaments.

### **5. How to register**

Projects must be sent by February 15th, 2024 at the latest, by email to [Info@international-molkky.org](mailto:Info@international-molkky.org)

The projects are composed as follows, with documents in A4 format and in PDF format :

- Conceptual note of the project (intentions, motivations, history of creation, etc.)
- Technical description (materials used, details, etc.)
- Contact details of the participant (s) (Name, first name, postal address, email address)
- Color drawing of the medals indicating the scale of the drawing (example: 1/2, 1/5, 1/10 scale, etc.)
- Drawings usable for IMO to manufacture those medals.

### **6. Intellectual and industrial property**

**6.1** The intellectual property and the resulting rights relating to the creation belong to the participant. The participant guarantees that his creation is his own and that it does not infringe any rights of third parties.

In particular, he assures IMO of the following :

- > The creation is original and has not been presented in any other competition or forum, either in writing or orally ;
- > The participant or group of participants is the exclusive author of the creation ;
- > The creation does not infringe the rights of third parties ;
- > On the date of presentation of the creation, the participant or the group of participants is the sole holder of the intellectual and industrial property of the creation ;
- > The creation was not created for a professional activity or for the provision of a service to a third person.

The participant releases the IMO from any responsibility in the event of a claim by a third party claiming an infringement of his rights and expressly guarantees IMO the reimbursement of all

compensation, costs, and possible convictions (including legal and procedural costs) in connection with such claims.

**6.2** In the event that the IMO decides to produce or have produced directly or through third parties, a winning project, or another project that has been proposed by a participant within the framework of the competition, a contract of model edition will then be signed with the creator (s) of the work, who will remain copyright owners.

**6.3** The participants expressly authorize the IMO, free of charge, to publish, communicate, exhibit and disclose orally, graphically or in writing the projects presented in the context of this competition. Each participant agrees to be publicized (photo, CV, etc.) and authorizes IMO, free of charge, to exploit his right to the image on all communication media attached to this competition.

## **7. The jury and the determination of the winners**

The jury is made up of members of the IMO board and representatives of IMO Members. The jury is sovereign and its decisions are final to control the progress of the competition and to settle in the last resort any contentious case. The jury will meet to elect the 1st prize.

## **8. The competition calendar**

- > Competition Deadline for sending files: February 15th, 2024
- > Publication of the name of the winners: April 1st, 2024
- > Prize giving: in August 2024 in Hakodate - Japan -, during the next World Championships

## **9. The rewards and the award ceremony**

### **> The 1st prize**

The winner (or the collective) of the 1st prize will win one registration for Mólky World Championship and one registration for one continental championship (non transferable and to be used in 2021 or 2022).

The IMO will personally contact the winner (or the collective) to inform them of their win.

The awards ceremony will take place in August 2024 in Hakodate - Japan -, during the next World Championships.

In the event that the winner is unable to attend, the IMO will send them their prize by post.

## **10. Acceptance of the rules**

Participation in this competition implies full and unreserved acceptance of these present regulations and any amendments thereof, forming the contractual law between the parties. In the event of force majeure, IMO reserves the right to postpone, shorten, extend or cancel this competition without liability being incurred. Candidates refrain from any claim or request for compensation in this regard.

## **11. Litigation**

In the event of a dispute, the parties will endeavor to settle their dispute amicably.
